6. Reports

Norfolk County Council

MD had previously circulated a report which is appended to these minutes and appears on the website. In addition he mentioned Ukrainian refugee children who were being provided with special help in schools, including interpreters.

North Norfolk District Council

The numbers of Covid infections, which were previously available from central government, are no longer being supplied by them. It is known that infections are dropping but there are still staff shortages in local hospitals partly due to Covid. There is now also a shortage of pharmacists due to the virus, and this has been reported to the government. In North Norfolk there are currently 35 Ukrainian children in schools, and these are being given special help. 95% of Council Taxpayers have now been provided with the government's £150 rebate. Those that do not pay by direct debit have been written to, inviting claims. 66% of North Norfolk is currently affected by the *Nutrient Neutrality* rules, preventing housebuilding even if it has already received planning permission. (This includes the 950 homes on the edge of Fakenham). Unless this is solved quickly, it will put more pressure on those areas in which it does not apply. Efforts are being made by RK to get NNDC assistance in the provision of a playground at the proposed affordable housing site in the village.

Homes for Wells/Flagship development

Jane Berwick had passed on a report from Flagship which does not promise the homes any time soon. RK is continuing to talk to the NNDC Housing Enablers to expedite them.

7) To discuss any planning matters to hand

There were no new applications. A short discussion took place on the scheme to "rewild" the River Stiffkey between Wighton and Warham. Warham PC had been unable to comment on this as Councillors could not reach a consensus.

8) To agree the annual audit governance statement for the year 2021/2022

It was agreed that we could answer positively to all the questions in the Annual Governance Statement, and this was signed off.

9) To agree accounts for 2021/2022 and sign off audit statement

It was agreed that the accounts could be signed off for the year. Also, the *Certificate of Exemption* as we continue to have a turnover (well) under £25,000. These were signed off by the Chairman and Clerk.

10) to Consider appeal for funds to train a local first responder

The ambulance service is trying to recruit six first responders to work in the Wells area. But it has been discovered that if people apply, they then have to pay £55 for the training. An appeal has been made to local Parish Councils to sponsor the training of one responder. It was agreed that we would do so if enough responders were recruited.
