No report has been received from either of the above organisations. However, it appeared that some preliminary work had been undertaken on the site

5) Planning Matters

Work re-naturalising River Stiffkey – amendment re soil spread zone.

Councillors were divided as to the merits of this scheme. We have concerns for local farmers regarding the loss of grazing land and wonder if the benefits outweigh this. We also believe that the work should be undertaken during the autumn and winter rather than the summer if it is not to disturb wildlife and also to assist farming operations.

6) To discuss the proposed fitting of timers to street lighting

A notice had been placed on the noticeboard towards the end of January stating that we intended to fit timers to the street lights so that they would be off between midnight and 6am during the winter (1.00am and 7.00am during British Summer Time). In view of the increased cost of electricity we believed that this was a better option than increasing the precept. The notice suggested that if anyone objected to this they should speak to any Councillor or the Clerk. Nobody had done so, so it was decided to go ahead with the scheme.

7) To discuss financial appeals from local organisations

Although we had two appeals posted to us, it was felt that our limited funds were better used on very local organisations. The Reading Room had lost several regular bookings since Covid, it was decided to donate £100 to them. Another £100 would be sent to the Burnham Market Car Service, which despite the name operates in Warham as well as other local villages. They provide volunteer transport for people to have medical appointments and also collect and deliver prescriptions.
